

# **Oxfordshire County Council Fire & Rescue**



## THE REGULATORY REFORM (FIRE SAFETY) ORDER 2005 (FSO)

The FSO introduced in 2006, replaced nearly all previous fire regulations and broadly brought the control of fire safety into a single piece of legislation. It places a general duty upon employers or owners of premises to ensure the safety of employees, and non-employees, to take such fire precautions as may reasonably be required in the circumstances to ensure that premises are safe and a duty to carry out a risk assessment.

Where five or more employees are involved, or the premises are licensed, the findings of the risk assessment must be in writing. The FSO imposes a number of specific duties in relation to the fire precautions to be taken. It applies to virtually all premises with the exception of domestic premises. In the case of working from home, a single person working from home, which does not involve clients entering the house will generally be held to still be domestic house, thus the FSO will not apply. Trading Standards are responsible for a wide range of legislation controlling the advertising, marketing, distribution and supply of consumer goods and services throughout the manufacturing, importation and retail chain. The Service has a Business Advice & Regulation Team who offer help and advice to Oxfordshire businesses to comply with the law in the following areas:

- Food labelling and standards,
- · Weights and measures,
- · Product safety e.g. toy safety, electrical equipment safety, cosmetic products
- Pricing;
- Unfair Trading Practices
- E commerce:
- Trade Marks (counterfeit goods)
- Under Age Sales
- Civil advice on contractual matters
- Excessive packaging
- · Overloaded vehicles & weight restrictions

# **District Councils - Environmental Health**



### **FOOD SAFETY**

The District Council Environmental Health Departments have a duty to ensure all food and drink produced, stored, distributed and sold within their area, is safe to eat. They support businesses to help them comply with food safety law and maintain legal standards of hygiene and safety.

New food hygiene laws came into force from I<sup>st</sup> January 2006. They affected all food businesses, including caterers, primary producers (such as farmers), manufacturers, distributors and retailers. Food business operators must comply with the provisions of the Food Hygiene (England) Regulations 2006, which also contain Temperature Control requirements, and the provisions of the Food Safety Act 1990.

Every food business, no matter what size and type, must take a risk based approach towards food safety and implement a food safety management system. This involves assessing the risk to food safety at all stages of the business from receipt to sale and where possible removing the risk or at least reducing the risk to a minimum. The food safety management system should be based on the HACCP principles (Hazard Analysis Critical Control Points). You must now keep up to date documents and records relating to your procedures.

There is a legal obligation on food businesses to register with the local District Council Environmental Health Department (see chapter 4 for contact details)

### **WORKPLACE HEALTH & SAFETY**

Environmental Health also aims to protect and improve the health, safety and welfare of workers, businesses and the public in Oxfordshire by regularly inspecting premises to advise on, and monitor compliance with, health and safety legislation.

The enforcement of health and safety is split between the Health and Safety Executive (HSE) and the Council. The HSE deals with issues of a specialist nature, whereas Environmental Health cover the smaller Service and Retail businesses.

# **Better Regulation in Oxfordshire**

The Oxfordshire Better Regulation Group is a local collaboration between Environmental Health Officers, Trading Standards Officers and Oxfordshire Fire and Rescue. The Group was created to ensure that a more consistent approach is taken by regulators when dealing with local businesses and that between them, the various agencies adopt better ways of working that would:

- · Reduce burdens on business
- Improve public protection
- · Improve workplace safety
- · Increase the efficiency of local authority regulatory services.

Two schemes introduced across Oxfordshire in 2009 illustrate what this means for local businesses:

### SCORES ON THE DOORS

Every one of Oxfordshire's cafes, restaurants, pubs and takeaways can now display a 'star rating' certificate issued after an inspection by their local Environmental Health team. As well as serving a very useful marketing tool, the star rating also provides a very useful steer as to how the business can improve. Through Oxfordshire Better Regulation Group, the Scores on the Doors scheme is operated in a consistent uniform way across all five Distracts. ### **SMARTER INSPECTION SCHEME**

To reduce some of the burdens on those local businesses who work hard to comply with all the rules and regulations and to ensure that local authority regulators concentrate their efforts on businesses that are struggling to comply or who choose to ignore advice and legal requirements, the Better Regulation Group has introduced a smarter way of working together.

Where an inspection is conducted by an Environmental Health Officer, Trading Standards Officer or Fire Safety Officer, a simple checklist will also be completed and shared with the other agencies. If no significant problems are found, it could avoid the need for other inspections by those other agencies. Of course, if a local business still prefers to see officers from all Regulatory Agencies, then this can be requested too.

By acting as the eyes and ears for each other, the local authority regulators can target resources to where they are needed most.
