# 1. INTERPRETATION

In this Deed the following terms and expressions shall have the following meanings: -

1.1	"the Footpath"	means the footpath that runs along the Land as more particularly described in Part I of the Schedule to this Agreement
1.2	"the Land"	means the land at Barton between Barton Village Road / Wick Farm Road and Bayswater Road
1.3	"the Plan"	means the plan annexed to this Agreement

The clause headings in this Agreement are included for convenience only and shall not affect its interpretation

# 2. RECITALS

- 2.1 The Owner is the registered proprietor of the freehold of the Land registered at HM Land Registry with title absolute under title numbers ON292187, ON292424, ON292700 and ON63116 shown shaded pink on the Plan through which the Footpath runs
- 2.2 It is intended to dedicate a right of way for the use of the public on foot only along the Footpath
- 2.3 The Council is the highway authority for the area within which the Land is situate and has had due regard to the needs of agriculture and forestry

#### 3 STATUTORY PROVISIONS

This Agreement is entered into pursuant to section 25 of the Highways Act 1980 and all other powers so enabling

# 4 **DEDICATION**

- 4.1 The Owner hereby dedicates for the use by the public on foot only all that part of the Land comprising the Footpath
- 4.2 The Council confirms that from the date on which this Agreement comes into effect the Footpath will be highway maintainable at public expense

#### 5 JURISDICTION

This Agreement shall be governed by and construed in accordance with the law of England

#### 6 DELIVERY

The provisions of this Deed shall be of no effect until this Agreement has been dated

#### PART I

#### **DESCRIPTION OF THE PATH**

ALL THAT strip of land shown by a broken black line on the Plan commencing at Ordnance Survey Grid Reference SP 5515 0822 (Point A on the Plan) at its junction with Barton Village Road / Wick Farm Road, in a north-easterly direction for 22 metres to SP 5517 0823 (Point B), then in an east-south-easterly direction for 36 metres to SP 5521 0822 (Point C) at its junction with Public Footpath No 145 Barton, then in a south-easterly direction for 113 metres to SP 5530 0816 (Point D) at its junction with Public Footpaths Nos 82, Barton and 19, Beckley and Stowood, then in an east-south-easterly direction for 112 metres to SP 5541 0813 (Point E), then in a south-south-easterly direction for 55 metres to SP 5542 0807 (Point F), and then in an east-south-easterly direction for 447 metres to SP 5585 0801 (Point G) at its junction with Bayswater Road, Barton, Oxford. The Footpath has a width of 2 metres for its entire length.


