Hailey Bridleway No. 35,
Public Path Creation and Definitive Map and Statement Modification Order
2023**

This Order is made by The Oxfordshire County Council ('the authority') under section 26 of the Highways Act 1980 because it appears to the authority that, having regard to the matters set out in section 26(1), there is a need for public bridleways and a restricted byway over the land to which this Order relates, and that it is expedient that these ways should be created.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Oxfordshire County Council Definitive Map and Statement of Public Rights of Way for Oxfordshire require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, the creation (as authorised by this Order) of new rights of way over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths.

West Oxfordshire District Council has been consulted as required by Section 26(3) of the Highways Act 1980.

BY THIS ORDER:

1. There shall be from the date of confirmation of this Order public rights of way over the land in the parishes of Hailey and North Leigh and shown by bold broken lines on the map attached to this Order and described in Part 1 of the Schedule to this Order, and thereupon the Oxfordshire County Council Definitive Map of Public Rights of Way for Oxfordshire shall be modified by adding those public rights of way, and the Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.

Description of Land

Hailey Bridleway No. 45

ALL THAT strip of land at Hailey, Oxfordshire shown as a bold broken line on the map attached to this Order running from North Leigh Lane at OS Grid Ref SP 3681 1387 (Point A on the Order plan) north-eastwards for approximately 19m to SP 3682 1388 (Point B) and east-north-eastwards for approximately 36m to SP 3686 1389 (Point P) at the North Leigh Parish boundary.

Width: 3 m.

North Leigh Restricted Byway No. 44

ALL THAT strip of land at North Leigh, Oxfordshire shown as a bold broken line on the map attached to this Order running from Wilcote Road at OS Grid Ref SP 3786 1483 (Point J on the Order plan) south-south-westwards for approximately 141m to SP 3781 1470 (Point K), westwards via SP 3770 1472 (Point L) for approximately 230m to SP 3759 1472 (Point M), south-south-westwards for approximately 558m to SP 3746 1419 (Point F), south-westwards for approximately 324m to SP 3711 1396 (Point D), and south-south-westwards for approximately 228m to SP 3716 1379 (Point O).

Width: 4 m., widening to 6m at SP 3770 1472 (Point L on the Order plan)

North Leigh Bridleway No. 45

ALL THAT strip of land at North Leigh, Oxfordshire shown as a bold broken line on the map attached to this Order running from Hailey BR35 at the Hailey Parish boundary at OS Grid Ref SP 3686 1389 (Point P on the Order plan) north-eastwards for approximately 364m to SP 3711 1396 (Point D).

Width: 3 m.

North Leigh Bridleway No. 46

ALL THAT strip of land at North Leigh, Oxfordshire shown as a bold broken line on the map attached to this Order running from North Leigh RB44 at OS Grid Ref SP 3746 1419 (Point F on the Order plan) north-eastwards via SP 3777 1452 (Point G) and SP 3785 1460 (Point H) for approximately 674m to the brook at SP 3794 1467 (Point X), crossing the brook north-eastwards over a bridle bridge for a distance of 5m and continuing north-eastwards for approximately 193m to Wilcote Road at SP 3713 1471 (Point I).

Widths: 3 m.

1.5m over bridle bridge.

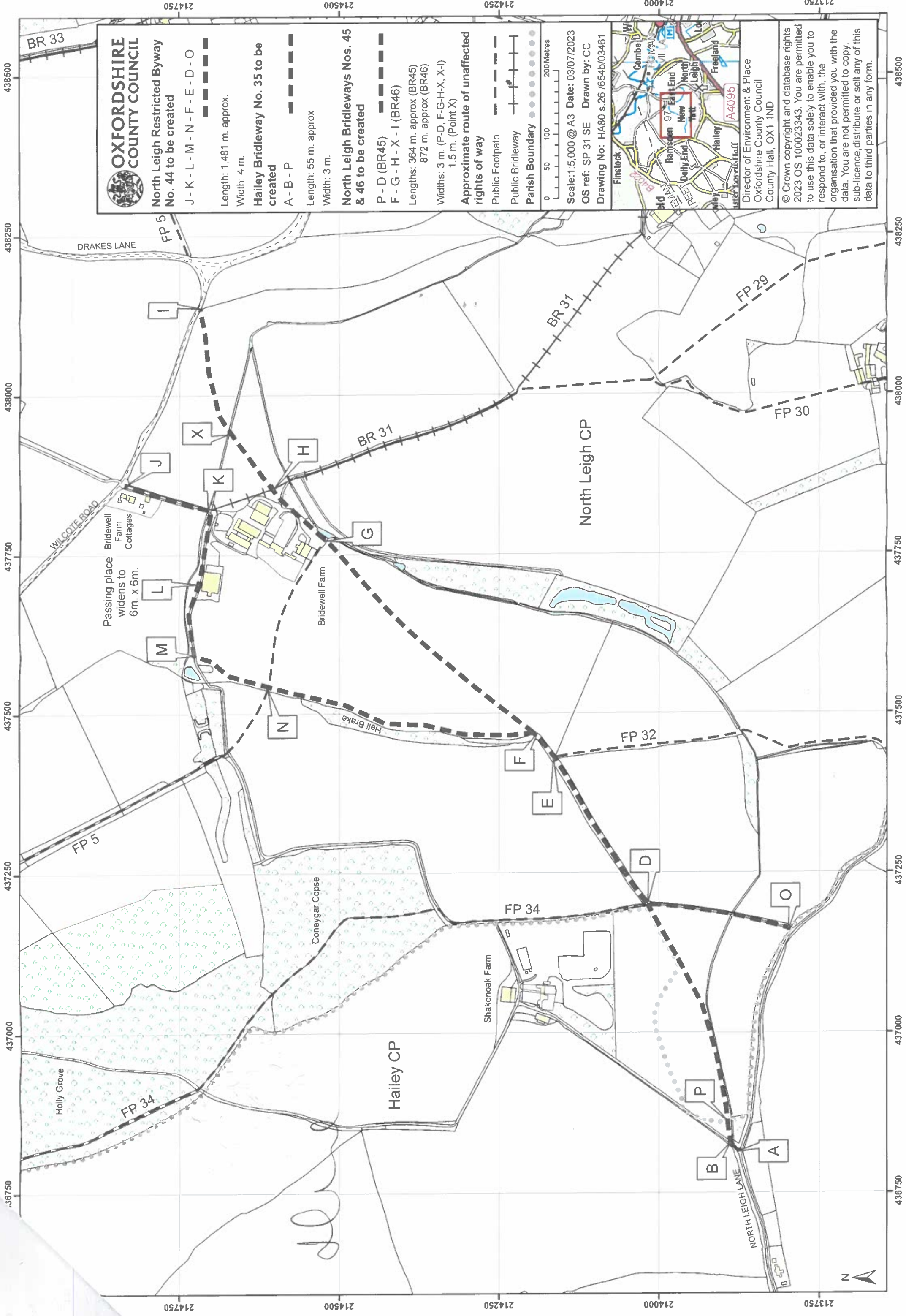


