OXFORDSHIRE COUNTY COUNCIL (OXFORD TOWN & GOWN 10K RUN) (SPECIAL EVENT) ORDER 2024

WHEREAS the Oxfordshire County Council ("the Council") is satisfied that traffic in Oxford should be temporarily prohibited from using various lengths of road to facilitate the holding of the Oxford Town and Gown Fun Run ("the Event") on 12 May 2024. The Council is satisfied that it is not appropriate for the Event to take place wholly off the road.

NOW THEREFORE the Council, in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 and all other enabling powers make the following Order:

 'bus' means a vehicle which is constructed or adapted to carry more than 8 passengers (exclusive of the driver) and a local bus not so constructed or adapted.

"taxi" means a vehicle licensed under (i) Section 37 of the Town Police Clauses Act 1847; or (ii) a Licenced / 'Private Hire Vehicle' under S80 Local Government (Miscellaneous Provisions) Act 1976 - a vehicle constructed or adapted to seat fewer than 9 passengers, other than a taxi or public service vehicle.

- 2. Save as provided by Article 3 of this Order, and subject to article 4, no person shall when appropriate signage is displayed, except upon the direction or with the permission of a police constable in uniform or the Council, cause a vehicle to proceed or wait in the lengths of road specified in the Schedule to this Order ("the Sections of Road") between the hours of 08.00 and 12.00 hours on Sunday 12 May 2024.
- 3. Nothing in Article 2 of this Order shall render it unlawful for a person to cause a vehicle to proceed, subject to the progress and safety of the event, in any of the Sections of Road specified in the Schedule to this Order if the vehicle is:
 - a) being used for the purpose of police, fire or ambulance services; or
 - b) being used in connection with emergency works to the roads, or to any sewer or any main pipe or apparatus for the supply of gas, water, electricity, or telecommunications in, or in any land adjacent to a length of road specified in the Schedule to this Order; or
 - c) being used by an authorised event official in support of and for safety reasons of the event: or
 - d) being used to enable access to premises, or to enable loading or unloading to take place at premises adjacent to the road.
- 4. Nothing in Article 2 of this Order shall render it unlawful for a Bus or Taxi to proceed in the south side (westbound lane) of High Street between Longwall Street and Cornmarket Street.
- 5. The prohibitions imposed by Article 2 shall apply in relation to any part of the Sections of Road to such extent and at such times as there are in place traffic signs within the meaning of section 64 of the Road Traffic Regulation Act 1984 indicating that such prohibition is in operation at that part.

- 6. The relevant provisions of the Oxfordshire County Council (City of Oxford) (Central Area) (Traffic Management) (Consolidation) Order 2003 (as amended) which prohibit entry to Turl Street from High Street and to Keble Road from Banbury Road will be temporarily suspended to provide for controlled access.
- 7. This Order may be cited as the Oxfordshire County Council (Oxford Town & Gown 10K Run) (Special Event) Order 2024 and shall have effect on 12 May 2024.
