What is being assessed (e.g. name of policy, procedure, project, service or proposed service change).	<p>22/23 Budget Proposals - Environmental and Community bids</p> <p>Development and implementation of a county wide Nature Recovery Strategy</p> <p>It is expected that the Environment Bill will introduce a requirement for Nature Recovery Strategies to be developed. It is further expected that upper tier authorities will be the lead authority to adopt and oversee such strategies and the government is currently consulting on what form such strategies might take so there remains uncertainty.</p> <p>Oxfordshire County Council (OCC) has done some preliminary work on the spatial component of such a strategy and the proposed new Local Nature Partnership will likely have a role in its further development. Following on from adoption of the strategy OCC is likely to have new duties under the Environment Bill to monitor and report progress. In addition to additional officer time noted as a new pressure there is expected to be a need to invest in the process and data and partnership working, which will be necessary to deliver the strategy. The timescales when this becomes a formal requirement are yet to be determined. This pressure is included to ensure that there is some recognition of the new demands that are expected, and as further details emerge, the actual values will need to be confirmed.</p> <p>Preparation of the strategy is just one part, there is ongoing delivery, monitoring and reporting which is why the pressure is maintained year on year. It may be that new burden funding is available from central government but there is no clarity on this yet.</p>
Is this a new or existing function or policy?	This is a new function, expected as a requirement of new government legislation.

<p>Summary of assessment</p> <p>Briefly summarise the policy or proposed service change. Summarise possible impacts. (following completion of the assessment).</p>	<p>The development, implementation and monitoring of a county-wide nature recovery strategy (NRS) has potentially significant and wide-ranging long-term impacts. As the government legislation that drives this policy has yet to receive Royal assent there remains considerable uncertainty. The primary purpose of the NRS will be to influence land use decisions and drive land use change at various scales. It is not currently possible to offer detail on the proposals that will emerge, as this will be the result of wide ranging, national stakeholder consultation. At this stage it is not intended or expected that the proposals will discriminate or unfairly disadvantage individuals or groups.</p>

The background will be set out in the regulations and guidance arising from the Environment Bill should it receive Royal Assent.</p>

<p style="text-align: center;">Proposals</p> <p>Explain the detail of the proposals, including why this has been decided as the best course of action.</p>	<p>It is likely that the county council will be asked by DEFRA to assume the role of Responsible Authority for the preparation of the NRS. As noted in the first section if the council takes on this new duty there will be a wide range of inputs required from various organisations to deliver a successful NRS. The full extent of these responsibilities is not known. This proposal is a first step to consider what resources may be required and allocate these. At present there is not considered sufficient capacity within the organisation to meet these new obligations. It is expected that this resource proposal alone will not be sufficient to meet all the requirements of developing the NRS. Contributions from other sources including local authority partners and central government may be required.</p>
<p style="text-align: center;">Evidence / Intelligence</p> <p>List and explain any data, consultation outcomes, research findings, feedback from service users and stakeholders etc, that supports your proposals and can help to inform the judgements you make about potential impact on different individuals, communities or groups and our ability to deliver our climate commitments.</p>	<p>The only firm evidence to date is the information contained in the evolving Environment Bill. DEFRA and some local bodies have organised workshops to pass on what current thinking is. This will however only become apparent once the Environment Bill receives Royal Assent.</p> <p>The NRS is expected to include consideration of key challenges such as climate change when identifying biodiversity priorities and considering the spatial distribution of habitat change. As such the outcomes of the proposal in the long-term are expected to be in line with the council's Climate Action Framework.</p>

<p>Alternatives considered / rejected</p> <p>Summarise any other approaches that have been considered in developing the policy or proposed service change, and the reasons why these were not adopted. This could include reasons why doing nothing is not an option.</p>	<p>As this is an early stage in the process and in the absence of formal guidance there are no alternatives to consider. It could be possible for the county council not to take up the role of Responsible Authority, however, the biodiversity issues to be determined are best considered at county scale and is in line with our strategic priorities to put action to address the climate emergency at the heart of our work. Even if not acting as Responsible Authority the county council would be expected to contribute to the development of the NRS.</p>
